

# MĀNGERE-ŌTĀHUHU ECONOMIC AND BUSINESS DEVELOPMENT FUND GUIDELINES

#### **About the Fund**

The Māngere-Ōtāhuhu Local Board have prioritised supporting economic development in the local board area by establishing an Economic and Business Development Fund of \$60,000.

The Māngere-Ōtāhuhu Local Board are committed to championing businesses in the local board area and facilitate them to identify and take advantage of economic opportunities - to grow local prosperity and employment. The Local Board are dedicated to improving the well-being of their local people by supporting their local economy to become more efficient, resilient, and sustainable through our reduced budget.

## Types of expenses covered by the Fund

Local businesses, not for profits and entrepreneurs within the Māngere-Ōtāhuhu Local Board area can apply for funding of up to \$2,000 towards equipment or tools, funding for training or to attend conferences, marketing, research or consultancy costs, seed funding for new businesses, sustainability initiatives, recovery assistance for businesses impacted by the recent devastating weather events or submit a proposal not outlined for consideration towards economic development.

## **Applications Criteria**

- Each application is capped at \$2,000
- Applications close 30 June 2023
- Businesses have to be located within the Māngere-Ōtāhuhu Local Board area.

- Businesses are required to have legal status for example Incorporated Society,
   Limited Liability Company, Charitable Trust and/or have a <u>New Zealand Business</u>
   <u>Number (NZBN)</u>. Any business operating in New Zealand can obtain a NZBN;
   whether you're a sole trader working from home, or a multi-national
   organisation, it's free to get an NZBN.
- Got a great business idea and just need some funding to help get started? Entrepreneur individuals or groups with no formal legal structure in New Zealand can apply under an "umbrella organisation". Umbrella organisations are organisations with a formal legal structure in NZ that have agreed to receive and administer the grant on the applicant's behalf. The umbrella organisation has



responsibility to provide full accountability of the grant, more details on Accountability are below.

#### **Funding process**

The Fund made available by Māngere-Ōtāhuhu Local Board is \$60,000 and will close at 8pm Friday 30 June 2023.

After the Fund closes, the process outlined below may take approximately up to two months, consistent with <u>Auckland Council's local grant policy</u>:

- a Panel will review applications;
- the Mangere-Ōtahuhu Local Board will consider applications;
- Applications will be notified if their submission has been awarded or not;
- Payments will be processed to successful applicants

There is a limited funding pool available. The decision to award funding is at the discretion of the Māngere-Ōtāhuhu Local Board and will be based on the merit of applications. Meeting the eligibility criteria does not guarantee that you will receive a funding grant.

## **Accountability**

- The Māngere-Ōtāhuhu Local Board requires that all successful applicants provide accountability upon competition of the project or activity. The applicant will be expected to provide receipts showing expenditure of the grant, any surplus or misused funds must be returned to Council.
